The Author **retains the copyright** for the Article/Review and this is acknowledged in the copyright line on your Article/Review. The Author asserts the moral right to be identified as the Author of the Article/Review.

Public Licence

1. The Author and the Journal Editor agree that the Author grants an Attribution-Noncommercial-No Derivative Works 3.0 Unported Creative Commons Licence in the Article/Review to the general public (see <http://creativecommons.org/licenses/by-nc-nd/3.0/>). This means that the article may be copied, distributed, displayed, and performed under the following conditions:

- Attribution: credit be given to the original author credit.
- Non-Commercial: no use for commercial purposes.
- No Derivative Works: the text may not be altered, transformed, or used to build upon.

2.
