Public Licence

1. The Author and the Publisher (the Journal Editor) agree that the Author may grant a Creative Commons Copyright Licence in the Article/Review to the general public. The Author should check one of the following options and initial the selection:

2. If not granted in paragraph 1, the Author grants to the Publisher a royalty-free, worldwide, non-exclusive license to publish, reproduce, display, distribute and use the Article/Review in any form, either separately or as part of a collective work, including (but not limited to) a non-exclusive license to publish the article in an issue of the Journal, authorize reproduction of the entire Article/Review in another publication, and authorize reproduction and distribution of the Article/Review by means of computerised retrieval systems. The Author retains the ownership of all rights under copyright in the Article, and all rights not expressly granted in this Agreement.

3. The Author agrees that the Journal be given credit as the original publisher in any republication of the Article/Review authorized by the Author. If the Publisher authorizes any other party to republish the article under the terms above, the Publisher shall require such party to ensure that the Author is properly credited.

Editing

The Author agrees that the Journal Editors may edit the Article/Review as suitable for publication in the Journal. The Editors agrees to publish the Article/Review subject to the understanding that the Article/Review will not be published in the Journal unless, in its final form, it is acceptable to both the Author and the Editors.
